<b>APPROVAL OF MINUTES</b>	Raymond Douglass made the motion to adopt the June 11, 2024 minutes. Michael Yohe seconded, all were in favor.

<b>SECRETARY/TREASURER REPORT</b>	<ul style="list-style-type: none"><li>• Balance Sheet as of July, 2024 was presented.</li><li>• Stickney Project – Grant Application – Multi-Modal Grant is in the works.</li><li>• A Special Meeting was held July 23, 2024 to discuss and approve a Resolution for a Multimodal Transportation Fund Grant of \$421,004.00 from the Commonwealth Financing Authority to be used for Stickney Trail and Wolf Run Road Reconstruction Project. Dennis Faucher and Lisa Godding will be the officials to execute all documents and agreements between the Corydon Township Municipality and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant. Raymond Douglass made the motion to adopt the Resolution. Michael Yohe seconded; all were in favor.</li></ul>
