

# CORYDON TOWNSHIP SUPERVISORS

## REGULAR MEETING

September 9, 2024

### CALL TO ORDER

The September 9, 2024 regular meeting of the Corydon Township Supervisors was called to order at 6:00 pm by Dennis Faucher, Chairman. The Pledge of Allegiance Followed.

### PRESENT

### APPROVAL OF MINUTES

Michael Yohe made the motion to adopt the August 13, 2024 minutes. Raymond Douglass seconded; all were in favor.

### NEW BUSINESS

- DCED Local Share Grant – Plow Truck Purchase – a grant is being written for the purchase of a plow truck for the 25/26 season.
- Liquid Fuels Tax Fund Audit – 1/1/2018 – 12/31/2022 – Findings from the audit were and unapproved expenditure of \$4892.12 was made, and the Township has been instructed to reimburse the Liquid Fuels account for that amount. A transfer from the General Fund to the Liquid Fuels Fund will be made.
- Plowing and Sanding – Lafayette Township and Mead Township – Mead Township will charge \$70 per trip for Kinzua Heights Road. Michael Yohe made a motion to approve, Dennis Faucher seconded; all were in favor.

### OLD BUSINESS

- DCED Multi-Modal Transportation Grant – Application Review Update – clarification was needed for the present condition of the roads.
- Road Bond Update – Names are needed for the companies that are using the heavy trucks on the bonded roads.

### ROAD DEPARTMENT REPORT

Dennis Faucher presented the August, 2024 Road Report:

- Maintenance on Ford
- Marked holes on Wolf Run for repair
- Mowed at Shop
- Finished Old State Road repair

### SECRETARY/TREASURER REPORT

- Balance Sheet as of August, 2024 was presented.

### APPROVAL TO PAY EXPENSES

A motion was made by Raymond Douglass to pay expenses, and a second by Michael Yohe. All were in favor.

### CITIZENS CONCERNS

Raymond Douglass discussed the County Hazard Mitigation Committee meeting he attended, and the role the Corydon Township has regarding meeting attendance, plan adoptions, PEMA requirements, and the Blanket Policy each Municipality has to have.
